YAKIMA CITY COUNCIL NOTICE OF APPEAL HEARING

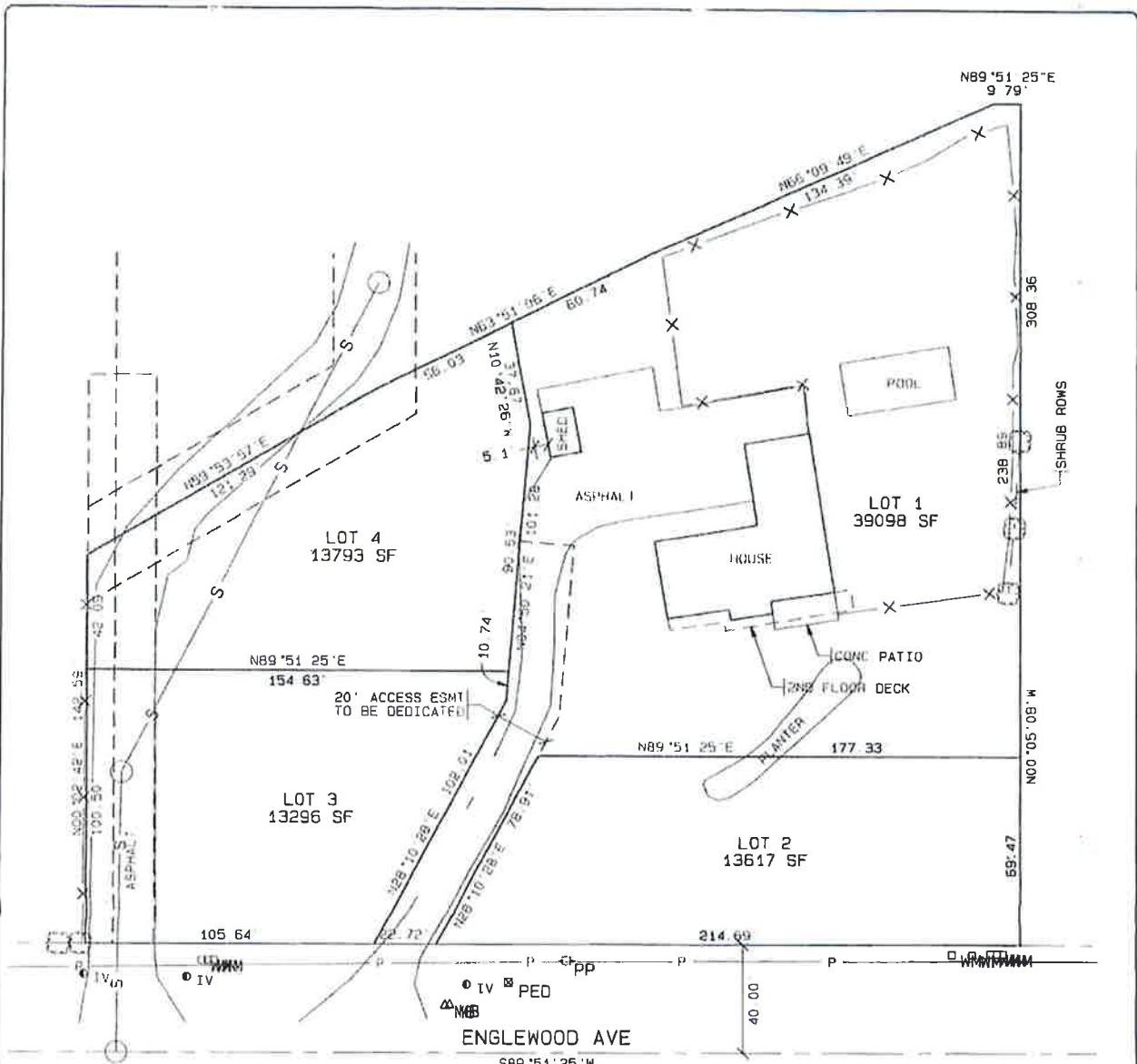

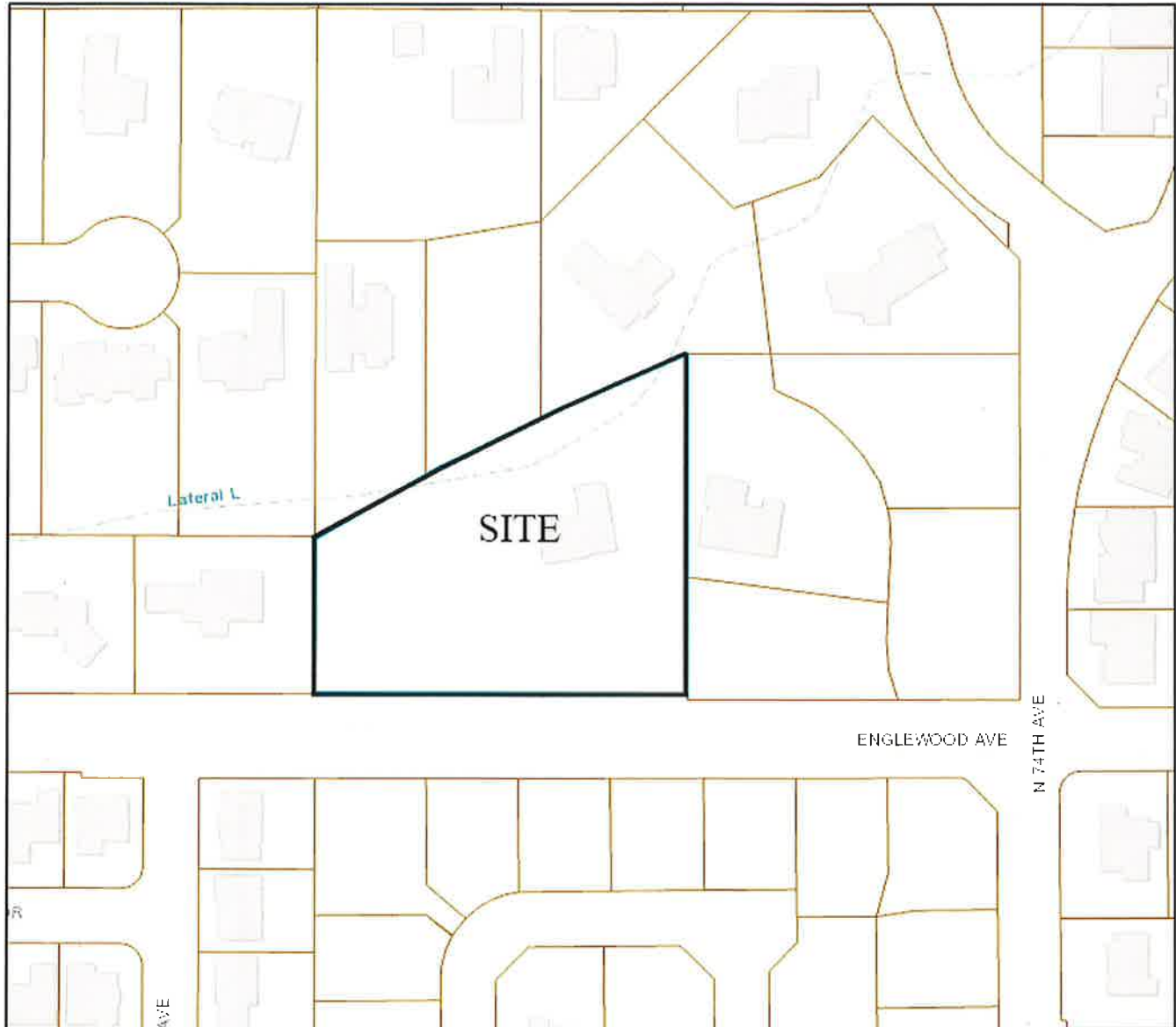
