NOTICE IS HEREBY GIVEN that the Yakima City Council will conduct a Closed Record Public Hearing to consider the Planning Commission's recommendation regarding preliminary plat approval of Rainier Court Phases 2, 3 and 4, submitted by Columbia Ridge Homes LLC. The plat is a residential subdivision of approximately 26 acres into 78 single-family residential lots located in the vicinity of N. 92nd Ave and Summitview Ave.

Said closed record public hearing will be held on **Tuesday**, **July 7**, **2020**, **at 6:00 p.m**., or soon thereafter, in the Council Chambers at City Hall located at 129 N. 2nd Street, Yakima, WA. *Closed Record Hearing* means the public is invited to testify on the existing Planning Commission's records but will not be allowed to introduce any new information.




VICINITY MAP
