RESOLUTION NO. R-2016-155

A RESOLUTION setting the time and place for hearing on January 10, 2017 at 6:30 PM in the City of Yakima Council Chambers to hear from the public on the City of Yakima assuming the rights, powers, functions and obligations of the City of Yakima Transportation Benefit District.

WHEREAS, the City of Yakima created a Transportation Benefit District on January 10, 2017 as authorized by RCW 35.21.225 and governed by the provisions of Chapter 36.73 RCW; and

WHEREAS, a public hearing must be held prior to the City of Yakima assuming all rights, powers, functions and obligations of such Transportation Benefit District pursuant to RCW 36.74.020,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF YAKIMA:

That assumption of the rights, powers, functions and obligations of the Transportation Benefit District by the City of Yakima shall be presented for hearing and determination by the City Council on Tuesday, January 10, 2017, at the hour of 6:30 p.m. in the Council Chambers of the City of Yakima, at Yakima City Hall, 129 N. 2nd Street, Yakima, Washington, or as soon thereafter as the same so that all persons interested may appear and be heard, and that notice of such hearing be given as approved by law.
