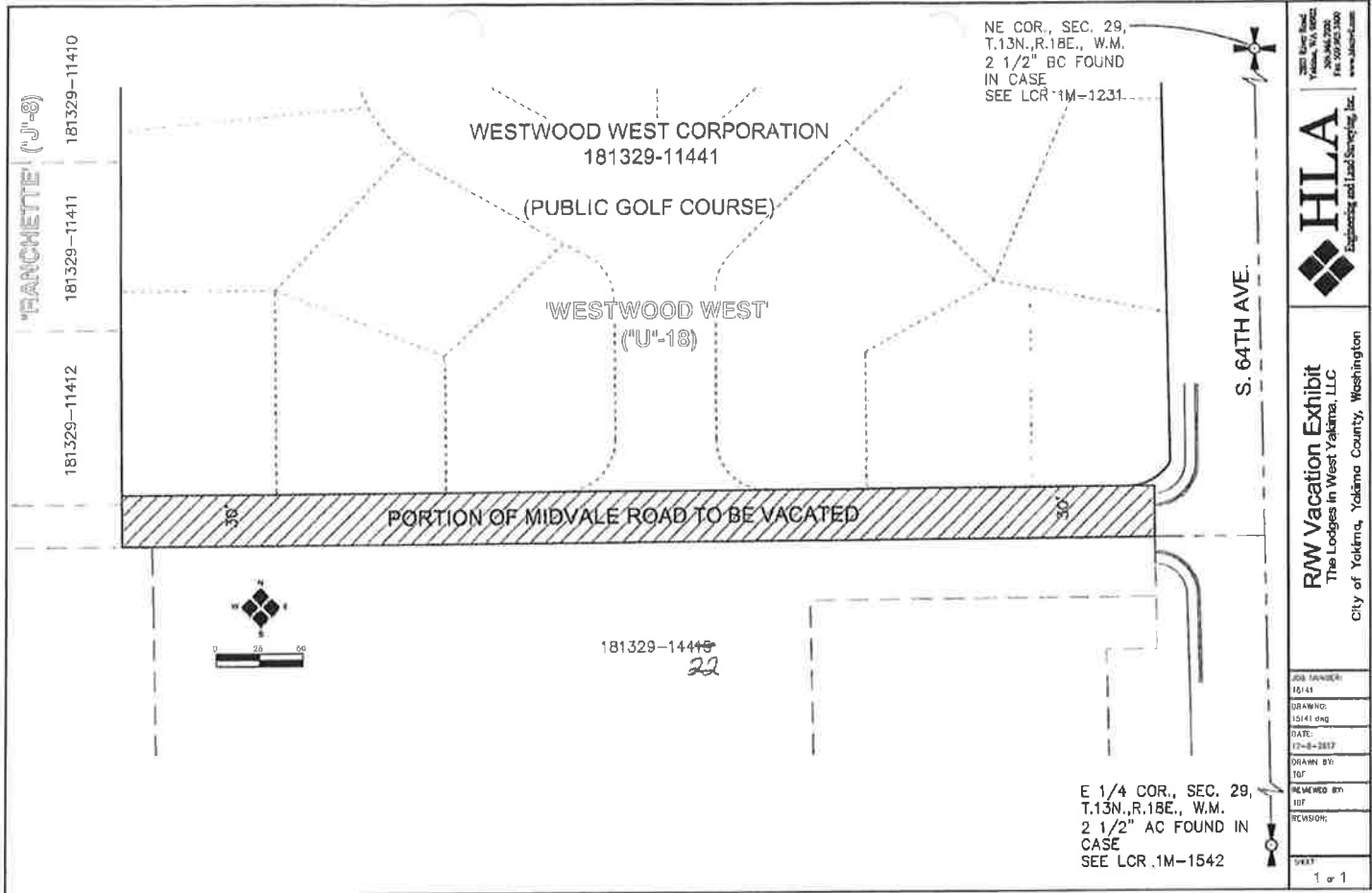

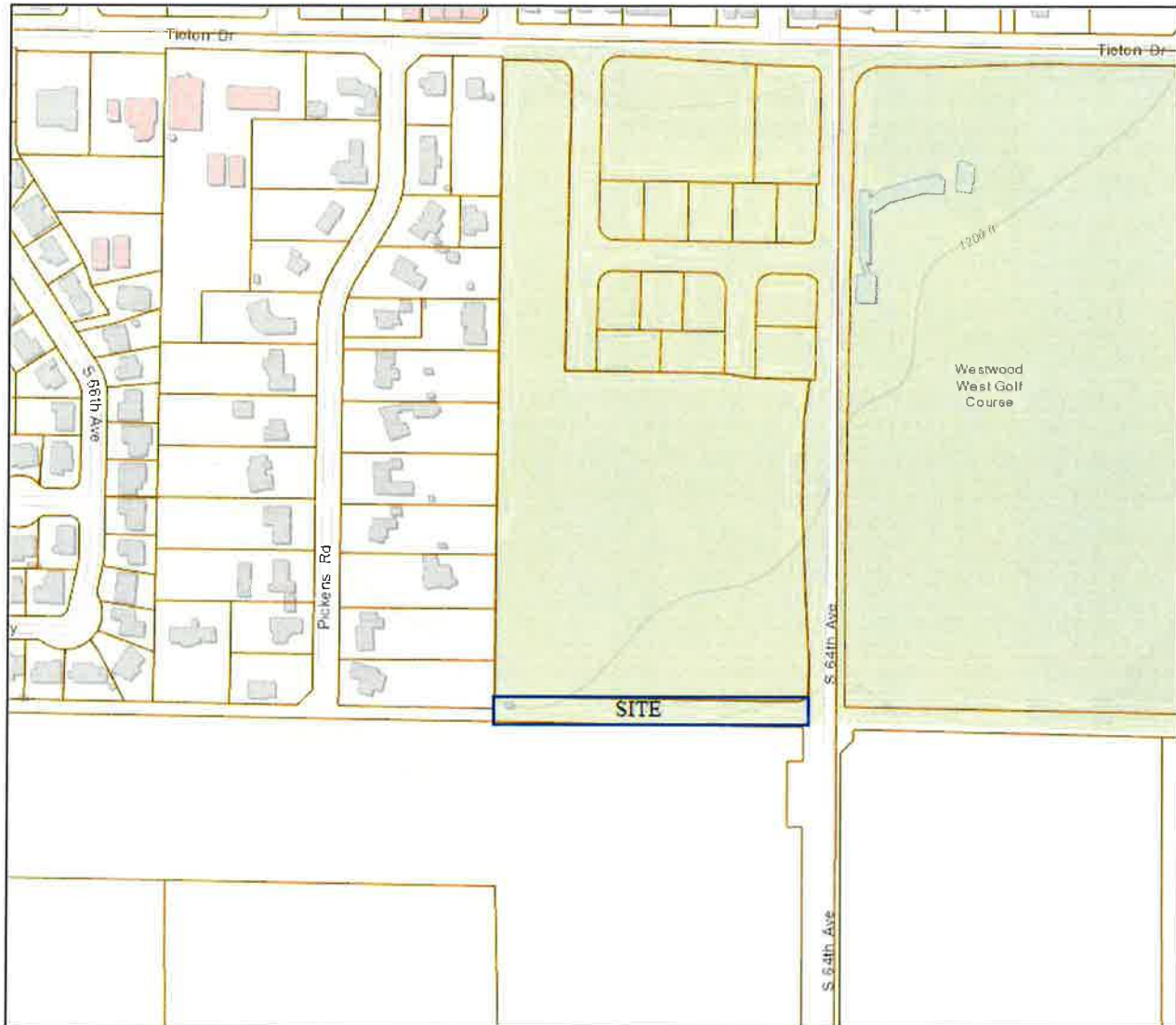
# VICINITY MAP
