Yakima City Council extends emergency declaration to June 4

An emergency declaration for the City of Yakima has been extended a second time and is in place through June 4th.

The Yakima City Council agreed to extend the declaration during its meeting on Tuesday, May 5th.

Council's action follows the decision by Gov. Jay Inslee on May 1st to extend his stay-athome orders through May 31st. It is in response to concerns about COVID-19, also known as the coronavirus.

Gov. Inslee has a 4-phase process to re-open the state's economy. A link to it is available on the City of Yakima's COVID-19 webpage - https://www.yakimawa.gov/covid 19/

All City buildings are closed to the public to help stem the spread of COVID-19.

The City continues to provide services to the community. See Page 4 in this issue for options to connect with the City by phone or online.

Mayor Patricia Byers signed the initial emergency declaration on March 12th, which took effect immediately.

Under state law, the full Yakima City Council needed to ratify the declaration in order for it to remain in effect long term. Council did so unanimously during a special meeting held March 13th.

Council then extended the order another 30 days during its meeting on Tuesday, April 7th.

Airport, Transit receive CARES grants



Yakima Airport qualifies for nearly \$1.3 million grant

Yakima Air Terminal-McAllister Field (YKM) has qualified for \$1,286,003 in federal funds through the Coronavirus Aid, Relief, and Economic Security (CARES) grant.

The Yakima City Council voted to apply and accept the grant funds during its regular meeting on Tuesday, May 5th.

The grant is part of a \$10 billion federal package providing assistance to airports in response to COVID-19 economic impacts.

Yakima Transit receiving more than \$6 million in funds

Yakima Transit will receive \$6,268,035 from the Federal Transit Administration as part of the CARES Act to assist with economic impacts as a result of COVID-19 (coronavirus).



Yakima Transit continues to take precautions to stem the spread of COVID-19. They include:

- Yakima Air Terminal-McAllister Field (YKM) has Daily disinfection procedures in all of its vehicles qualified for \$1,286,003 in federal funds through and facilities.
 - Bus operators wear personal protective equipment (masks and gloves) while on duty.
 - Plexiglass doors installed in buses between transit drivers and the public.
 - Since City facilities are closed due to the pandemic, bus passes and tickets can be purchased at the Transit Center, located at South 4th Street and Walnut Avenue, calling 575-6175 or at Wray's grocery stores in Yakima. Bus passes will be mailed if ordered via telephone.

Fisher Park Golf opens for the 2020 season with protocols in place

The City's Fisher Park Golf Course opened on May 5th with safety in mind.

Some of the precautions include:

- Golfers should bring their own hand sanitizer or antibacterial wipes and use them during and after their round.
- To minimize exposure to staff, the clubhouse will be closed entirely for all services and Personal Protective Equipment (PPE) will be provided to all golf course staff.
- Golfers must prepay their tee time online at https://yakimaparks.com/ and show paper or electronic receipt at check-in window.
- Twosomes will only be allowed at this time. However, if all golfers are from the same household they will be able to golf together up to a maximum of four golfers.
- Rental clubs, pull carts and motorized golf carts will not be available.
- Players must not touch the flagstick and must leave the pin in place at all times.

Downtown Farmers Market to open with social distancing

The Downtown Yakima Farmers Market (DYFM) is tentatively scheduled to open May 24th.

The market is held on 3rd Street, in front of the Capitol Theatre. It will be open each Sunday from 9 am to 1 pm through October 11th.

The Governor's restriction on public gatherings does not include farmers' markets as they are considered essential businesses in the same category as a grocery store. However, they are still a public gathering and many safety measures must be installed and managed.

Precautions will include:


- A designated entrance and exit,
- Movement through the market will be oneway.
- Social distancing will be enforced along with no sampling or touching of products.
- Visitors will be asked to limit shopping time.
- Handwashing stations will be in place.


The market is administered by the Downtown Association of Yakima.

City unveils new Yak Back

The City of Yakima's popular Yak Back app has a new look and new options thanks to an upgrade that was completed in April by the City's Information Technology Services staff.

Improvements include the use of Geographic Information Systems (GIS) to provide users an interactive map for tracking their Yak Back requests and to see locations of other Yak Back requests in the City. As with the current app, the improved Yak Back will show City staff responses to requests posted by residents.

The app is also available in Spanish, thanks to the upgrade.


