Over 200 small businesses receive grants


City Council sets aside funds to aid with COVID-19 relief

More than 200 small businesses in the city of Yakima received over \$1.4 million in grants the Yakima City Council set aside from federal funds to assist with impacts due to COVID-19.

In July, Council set aside \$480,000 from a Community Development Block Grant (CDBG), a Federal program intended to expand economic opportunities for low and moderate-income persons.

The Council made funds available to the smallest businesses in the City, those with five or fewer employees. Eligible businesses received up to \$10,000 for expenses due to COVID-19.

In September, Council dedicated an additional \$1 million for small business assistance with no repayment requirements. Grant funds were from the federal Coronavirus Aid, Relief, and Economic Security (CARES) Act.




The grant was set aside for businesses in the city limits with 25 or fewer employees.

As with the CDBG grant, businesses could apply for up to \$10,000 in CARES grant funding to assist with impacts from the COVID-19 pandemic.

In October, Council set aside \$1.4 million from a second round of CARES grant funds to assist non-profit corporations in the city limits.

The City Council will receive an update at a later date about results from the Yakima CARES grants for non-profit organizations.

City of Yakima launches drinking water campaign

Using a wide-range of communication tools, the City of Yakima is promoting its award-winning drinking water.

Two weeks ago the City launched a drinking water campaign on its website at

There are plans to air an interview with Assistant Public Works Director Dave Brown on an episode of "Y-PAC Checkins" to discuss the City's water. Y-PAC programming is available on Charter Spectrum Channel 194. Y-PAC's rotation of public service announcements includes infographics for the #WaterWednesday social media posts.

During its meeting on October 20th, the Yakima City Council noted the health benefits of fluoride in City water, the cost-savings for residents in drinking tap water rather than purchasing bottled water and the environmental benefits of reduced plastic consumption by drinking less bottled water and more City of Yakima tap water.

The City Council's discussion in October followed an announcement in August that the City of Yakima Water Treatment Plant received the Gold Certificate of Achievement for 10 years of outstanding performance.

The Gold Certificate of Achievement award was presented to the City of Yakima by the Washington State Department of Health (DOH) Office of Drinking Water.

It honored the City water treatment plant for consistently meeting the high standards of DOH's Treatment Optimization Program for 10 continuous years, 2010-2019.

The City of Yakima is one of just eight recipients in Washington state to receive the DOH Gold Certificate of Achievement this year.

Blue Star Memorial ceremony Nov. 11 at Tahoma Cemetery

A Blue Star Memorial will be dedicated at the City of Yakima Tahoma Cemetery this Veterans Day, Wednesday, Nov. 11th.

It will be placed near the veterans section of Tahoma Cemetery to honor all who served in the U.S. Armed Services.

The Blue Star Memorial dedication will take place at 11:00 am on Nov. 11th.

The public is invited to attend, with social-distancing protocols required.

The Yakima City Council approved the memorial in March. This will be the first Blue Star marker in the city of Yakima.



The Central District of Washington State Federation of Garden Clubs (WSFGC) initiated the effort for a marker and ceremony, and purchased the Blue Star Memorial.

The Blue & Gold Star Memorials Program honors all men and women who have served in the United States Armed Services. This program began with the planting of 8,000 Dogwood trees by the New Jersey Council of Garden Clubs in 1944 as a living memorial to veterans of World War II.

In 1945, the National Council of State Garden Clubs adopted this program and began a Blue Star Highway system that covers thousands of miles across the Continental United States, Alaska, and Hawaii with metal Blue Star Memorial Highway Markers.

"That is really the easiest way for people to donate toys at the Harman Center since we don't have specific times we are open to the general public," said Richards.

Powerhouse Road closure continues

A section of Powerhouse Road is closed 24/7 due to a sewer main extension project. The project is from Riverview Manor mobile home court to just short of Cowiche Canyon Road.

The closure began October 21st and is expected to last about a month to allow for re-paving the roadway this year.

Residents at the south end of the project area will have access from 40th Avenue. Those at the north end of the project area will have access from Ackley Road, off of U.S. Highway 12.

Because of heavy traffic volume, drivers can expect delays in the area. Drivers should use alternate routes until the work is completed.

Drivers are reminded that the speed limit through all traffic-related work zones within the City of Yakima is 20 miles-per-hour.

Access to homes and businesses in the project area will be maintained as best as possible and emergency vehicles will be allowed through the project area if necessary.

As always, the schedule for this type of project is subject to change daily dependent on weather, equipment, and emergencies.

City of Yakima 2020 budget receives award

The City of Yakima's 2020 budget has earned the Distinguished Budget Presentation Award from the Government Finance Officers Association (GFOA).

The 2020 budget received the honor for comprehensive planning, financial integrity and effective communication.

City finance staff strive to make incremental improvements each year in order to make Yakima an increasingly well-managed city.

City of Yakima technical accounting is provided by Jen Morris. Also, Kathy Miles contributes the complex programming to link financial numbers into the reporting software that produces a budget that is interesting, educational, slightly entertaining and, most importantly, informative for residents.

Budget documents considered for the GFOA award are rated by three independent reviewers who typically work in similar roles in other cities. They are judged on criteria as a policy document, an accountable financial plan, a transparent operations guide and communications vehicle.
