I acknowledge that I have requested services from the City of Yakima which may require access to the aforementioned premises. I understand that only the area covered by graffiti will be abated by painting over the graffiti, not the entire structure. I also acknowledge that the color of the paint will be determined solely by the City and likely will not match with the paint currently on the structure. I acknowledge that the quality of the services or materials used in performing this graffiti abatement are determined solely by the City. I understand that if the City does not have available funding or personnel that I am responsible for removing graffiti from my property.

I give permission to the City of Yakima, its contractors and agents, to enter my property to abate the graffiti using methods that the City and/or its contractors or agents decides, but I acknowledge that they are not obligated to do so. Additionally, I acknowledge that there are no concealed hazards on the property. I will provide safe access to the areas necessary to paint out and abate the graffiti if the City contacts me at least 24 hours in advance of work on the property. I waive my right to receive formal notice under 11.11.030 before entry onto my property for graffiti abatement.

By signing below, I release, discharge and hold harmless the City of Yakima, its elected and appointed officials, employees, contractors, insurers, volunteers and agents from any and all claims, causes of action, demands, rights, damages, costs, loss of service, expenses, legal expenses, including subrogation or liens, for injuries or damages caused by or related to actions, services and vehicles of the City of Yakima, its contractors, employees, volunteers and/or agents, while performing the requested services regarding graffiti outlined in this document, unless such damage is caused by the willful misconduct of the City, its officials, employees, contractors, agents and volunteers.

This consent and release of liability shall be effective on the date of execution and remain in effect through December 31st of the year outlined below, or until modified or terminated, in writing:

- Property Owner (5 years), Property Manager (2 years), Tenant (1 year)

I acknowledge that this permission does not automatically renew after termination and I am responsible for renewing the permission under the Graffiti Abatement Program. I understand that I may revoke or terminate this permission at any time by notifying the City of such revocation in writing. City may revoke by sending a Notice of Revocation in writing. If the property is sold or otherwise transferred prior to the expiration date, I shall notify the City in writing of such transfer so that a new permission may be obtained from the new owner of record. Permission is not transferrable.

I certify under penalty of perjury of the laws of the state of Washington that I am the:

- Property Owner, Property Manager, Tenant of Single or Two-Family Residence

If I am the property owner of a single or two-family residence that is tenant-occupied, I agree to provide the City notice when tenants vacate and/or move into my property.

I have read this entire document and I have authority to execute this document for the purposes described herein. I agree that if I am signing this without authority I am fully responsible for any damages, claims or costs associated with the City's reliance on this document.
