PARKING LOT PERMIT APPLICATION PACKET

Parking Lot Permit

A parking lot permit is required for the re-striping of an existing parking lot or for the creation of a new parking lot. If a building permit or grading permit is also being submitted for the site, a parking lot permit may not be required.

For establishing a new parking lot, land use review may be required. You may contact the Planning Division at (509) 575-6183 or <u>ask.planning@yakimawa.gov</u> to confirm if land use review will be required.

Two (2) copies of the site plan must submitted for review with this permit application, or you may submit online by following the directions on our website: <u>https://www.yakimawa.gov/services/codes/permits/</u>

Two (2) copies of drainage plans are also required if the project consists of creating a new parking lot.

An inspection fee is required to be paid before or at the time of permit issuance. For questions regarding fee or plan submittal and/or building code questions, please contact us at 509-575-6126 or <u>codes@yakimawa.gov</u>.
