

STORMWATER PERMIT APPLICATION PACKET

For projects that involve the development/re-development of more than 5,000 square feet of new and/or hard surface area and involve less than the clearing/grading of 1-acre or more and is not part of a larger common plan of development.

Submittal documents:

- 1) Completed Stormwater Permit Application.
- 2) Two (2) copies of stormwater design plans, specifications and run/off/storage calculations supporting the stormwater design, pursuant to Eastern Washington Stormwater Manual and City of Yakima standards.

Applications may be submitted to the City of Yakima Office of Code Administration, 129 N 2nd St., 2nd floor, Yakima WA 98901, between the hours of 8:30 a.m. – 4:30 p.m. There is no fee for this permit type.

The plans and control measures must be completed by a licensed Professional Engineer and then be reviewed and approved by the City of Yakima Surface Water Engineer <u>prior to construction</u>.

UIC Registration – Stormwater: In accordance with Chapter 2 Section 2.4 of the December 2006 edition of the Department of Ecology's Guidance for UIC Wells that Manage Stormwater Publication Number 05-10-067, Underground Injection Control (UIC) wells constructed on or after February 3, 2006 are considered new and must be registered with the Department of Ecology (DOE) prior to construction.
