<p><b>Section 1.0 - Statutory Authorization, Findings of Fact, Purpose, and Objectives</b></p>	<p><i>(Not mandatory to adopt section 1.0)</i></p>
<p><b>1.1 Statutory Authorization</b></p> <p>The Legislature of the State of Washington has delegated the responsibility to local communities to adopt floodplain management regulations designed to promote the public health, safety, and general welfare of its citizenry. Therefore, the <b>{Decision Making Body}</b> of <b>{Community Name}</b>, does ordain as follows:</p>	<p><b>15.27.100 Authority.</b> <b>15.27.400 Flood Hazard Areas Established.</b></p>
<p><b>1.2 Findings of Fact</b></p> <p>The flood hazard areas of <b>{Community Name}</b> are subject to periodic inundation, which may result in loss of life and property, health and safety hazards, disruption of commerce and governmental services, extraordinary public expenditures for flood protection and relief, and impairment of the tax base, all of which adversely affect the public health, safety, and general welfare.</p> <p>These flood losses may be caused by the cumulative effect of obstructions in areas of special flood hazards that increase flood heights and velocities, and when inadvertently anchored, damage uses in other areas. Uses that are inadequately flood proofed, elevated, or otherwise protected from flood damage also contribute to the flood loss.</p>	

<p><b>1.3 Statement of Purpose</b></p> <p>It is the purpose of this ordinance to promote the public health, safety, and general welfare; reduce the annual cost of flood insurance; and minimize public and private losses due to flood conditions in specific areas by provisions designed to:</p> <ol style="list-style-type: none"> <li>1) Protect human life and health;</li> <li>2) Minimize expenditure of public money for costly flood control projects;</li> <li>3) Minimize the need for rescue and relief efforts associated with flooding and generally undertaken at the expense of the general public;</li> <li>4) Minimize prolonged business interruptions;</li> <li>5) Minimize damage to public facilities and utilities, such as water and gas mains; electric, telephone, and sewer lines; and streets and bridges located in flood hazard areas;</li> <li>6) Help maintain a stable tax base by providing for the sound use and development of flood hazard areas so as to minimize blight areas caused by flooding;</li> <li>7) Notify potential buyers that the property is in a Special Flood Hazard Area;</li> <li>8) Notify those who occupy flood hazard areas that they assume responsibility for their actions; and</li> <li>9) Participate in and maintain eligibility for flood insurance and disaster relief.</li> </ol>	<p><b>15.27.120 Purpose.</b></p>
<p><b>1.4 Methods of Reducing Flood Losses</b></p> <p>In order to accomplish its purposes, this ordinance includes methods and provisions for:</p> <ol style="list-style-type: none"> <li>1) Restricting or prohibiting development that is dangerous to health, safety, and property due to water or erosion hazards, or which result in damaging increases in erosion or in flood heights or velocities,</li> <li>2) Requiring that development vulnerable to floods be protected against flood damage at the time of initial construction;</li> <li>3) Controlling the alteration of natural floodplains, stream channels, and natural protective barriers, which help accommodate or channel floodwaters;</li> <li>4) Controlling filling, grading, dredging, and other development, which may increase flood damage; and</li> <li>5) Preventing or regulating the construction of flood barriers that unnaturally divert floodwaters or may increase flood hazards in other areas.</li> </ol>

<p><b>*Alteration of watercourse:</b> Any action that will change the location of the channel occupied by water within the banks of any portion of a riverine waterbody.</p> <p><b>Appeal:</b> A request for a review of the interpretation of any provision of this ordinance or a request for a variance.</p> <p><b>*Area of shallow flooding:</b> A designated zone AO, AH, AR/AO or AR/AH (or VO) on a community's Flood Insurance Rate Map (FIRM) with a one percent or greater annual chance of flooding to an average depth of one to three feet where a clearly defined channel does not exist, where the path of flooding is unpredictable, and where velocity flow may be evident. Such flooding is characterized by ponding or sheet flow. Also referred to as the sheet flow area.</p> <p><b>*Area of special flood hazard:</b> The land in the floodplain within a community subject to a 1 percent or greater chance of flooding in any given year. It is shown on the Flood Insurance Rate Map (FIRM) as zone A, AO, AH, A1-30, AE, A99, AR (V, VO, V1-30, VE). <p><b>Breakaway wall:</b> A wall that is not part of the structural support of the building and is intended through its design and construction to collapse under specific lateral loading forces, without causing damage to the elevated portion of the building or supporting foundation system.</p>	<p>N/A</p>
<p><b>Coastal High Hazard Area:</b> An area of special flood hazard extending from offshore to the inland limit of a primary frontal dune along an open coast and any other area subject to high velocity wave action from storms or seismic sources. The area is designated on the FIRM as zone V1-30, VE or V.</p>	<p>N/A</p>
<p><b>Critical Facility:</b> A facility for which even a slight chance of flooding might be too great. Critical facilities include (but are not limited to) schools, nursing homes, hospitals, police, fire and emergency response installations, and installations which produce, use, or store hazardous materials or hazardous waste.</p>	<p>Added</p>
<p><b>*Development:</b> Any man-made change to improved or unimproved real estate, including but not limited to buildings or other structures, mining, dredging, filling, grading, paving, excavation or drilling operations or storage of equipment or materials located within the area of special flood hazard.</p>	<p>Y</p>

<p><b>Elevated Building:</b> For insurance purposes, a non-basement building that has its lowest elevated floor raised above ground level by foundation walls, shear walls, post, piers, pilings, or columns.</p>	<p>Added</p>

The term "manufactured home" does not include a "recreational vehicle."</p> <p><b>Manufactured Home Park or Subdivision:</b> A parcel (or contiguous parcels) of land divided into two or more manufactured home lots for rent or sale.</p> <p><b>*Mean Sea Level:</b> For purposes of the National Flood Insurance Program, the vertical datum to which Base Flood Elevations shown on a community's Flood Insurance Rate Map are referenced.</p> <p><b>*New construction:</b> For the purposes of determining insurance rates, structures for which the "start of construction" commenced on or after the effective date of an initial Flood Insurance Rate Map or after December 31, 1974, whichever is later, and includes any subsequent improvements to such structures. <p><b>*Start of construction:</b> Includes substantial improvement and means the date the building permit was issued, provided the actual start of construction, repair, reconstruction, rehabilitation, addition, placement, or other improvement was within 180 days from the date of the permit. The actual start means either the first placement of permanent construction of a structure on a site, such as the pouring of slab or footings, the installation of piles, the construction of columns, or any work beyond the stage of excavation; or the placement of a manufactured home on a foundation. Permanent construction does not include land preparation, such as clearing, grading, and filling; nor does it include the installation of streets and/or walkways; nor does it include excavation for a basement, footings, piers, or foundations or the erection of temporary forms; nor does it include the installation on the property of accessory buildings, such as garages or sheds not occupied as dwelling units or not part of the main structure. <p><b>3.2 Basis for Establishing the Areas of Special Flood Hazard</b></p> <p>The special flood hazard areas identified by the Federal Insurance Administrator in a scientific and engineering report entitled “The Flood Insurance Study (FIS) for <b>{exact title of study}</b>” dated <b>{date}</b>, and any revisions thereto, with accompanying Flood Insurance Rate Maps (FIRMs) dated <b>{date}</b>, and any revisions thereto, are hereby adopted by reference and declared to be a part of this ordinance. The FIS and the FIRM are on file at <b>{community address}</b>.</p> <p>The best available information for flood hazard area identification as outlined in Section 4.3-2 shall be the basis for regulation until a new FIRM is issued that incorporates data utilized under Section 4.3-2.</p>	<p><i>Mandatory (44 CFR 60.3 (preamble) and 44 CFR 60.2(h)). *In some communities, the phrase “and any revisions thereto” is not considered legally binding and should not be adopted.</i></p> <p><b>15.27.400 Flood hazard areas established. <p><b>3.3 Compliance</b></p> <p>All development within special flood hazard areas is subject to the terms of this ordinance and other applicable regulations.</p>	<p><i>Mandatory (44 CFR 60.2(h))</i></p> <p><b>15.27 Part 4 Flood Hazard Areas</b></p>
<p><b>3.4 Penalties For Noncompliance</b></p> <p>No structure or land shall hereafter be constructed, located, extended, converted, or altered without full compliance with the terms of this ordinance and other applicable regulations. Violations of the provisions of this ordinance by failure to comply with any of its requirements (including violations of conditions and safeguards established in connection with conditions), shall constitute a misdemeanor. Any person who violates this ordinance or fails to comply with any of its requirements shall upon conviction thereof be fined not more than _____ or imprisoned for not more than ___ days, or both, for each violation, and in addition shall pay all costs and expenses involved in the case. <p><b>3.6 Interpretation</b></p> <p>In the interpretation and application of this ordinance, all provisions shall be:</p> <ol style="list-style-type: none"> <li>1) Considered as minimum requirements;</li> <li>2) Liberally construed in favor of the governing body; and,</li> <li>3) Deemed neither to limit nor repeal any other powers granted under state statutes.</li> </ol>	<p style="text-align: right;"><i>Recommended (Not mandatory)</i></p> <p><b>15.27.404 Interpretations</b></p>
<p><b>3.7 Warning and Disclaimer of Liability</b></p> <p>The degree of flood protection required by this ordinance is considered reasonable for regulatory purposes and is based on scientific and engineering considerations. Larger floods can and will occur on rare occasions. Flood heights may be increased by man-made or natural causes. This ordinance does not imply that land outside the areas of special flood hazards or uses permitted within such areas will be free from flooding or flood damages. This ordinance shall not create liability on the part of <b>{Community Name}</b>, any officer or employee thereof, or the Federal Insurance Administration, for any flood damages that result from reliance on this ordinance or any administrative decision lawfully made hereunder.</p>	<p style="text-align: right;"><i>Recommended (Not mandatory)</i></p> <p><b>15.27.406 Revised Warning and disclaimer of liability.</b></p>
<p><b>3.8 Severability</b></p> <p>This ordinance and the various parts thereof are hereby declared to be severable. <p><b>4.1 Establishment of Development Permit</b></p> <p><b>4.1-1 Development Permit Required</b></p> <p>A development permit shall be obtained before construction or development begins within any area of special flood hazard established in Section 3.2. The permit shall be for all structures including manufactured homes, as set forth in the “Definitions,” and for all development including fill and other activities, also as set forth in the “Definitions.”</p>	<p style="text-align: right;"><i>Mandatory (44 CFR 60.3(b)(1))</i></p> <p><b>15.27.416 Permit-Required. <p><b>4.1-2 Application for Development Permit</b></p> <p>Application for a development permit shall be made on forms furnished by the Floodplain Administrator and may include, but not be limited to, plans in duplicate drawn to scale showing the nature, location, dimensions, and elevations of the area in question; existing or proposed structures, fill, storage of materials, drainage facilities, and the location of the foregoing. <b>APPENDIX A - STANDARDS FOR SHALLOW FLOODING AREAS (AO ZONES)</b>	(44 CFR 60.3(c)7, 8 and 11)
<p>Shallow flooding areas appear on FIRMs as AO zones with depth designations. The base flood depths in these zones range from 1 to 3 feet above ground where a clearly defined channel does not exist, or where the path of flooding is unpredictable and where velocity flow may be evident. Such flooding is usually characterized as sheet flow. In addition to other provisions in this code, the following additional provisions also apply in AO zones:</p> <ol style="list-style-type: none"> <li>1. specifications and plans for the construction, and shall certify that the design and methods of construction to be used are in accordance with accepted standards of practice for meeting the provisions of subsections (1)(a)(i) and (2)(a)(ii).

Obtain the elevation (in relation to mean sea level) of the bottom of the lowest structural member of the lowest floor (excluding pilings and columns) of all new and substantially improved structures in zones V1-30, VE, and V on the community's FIRM and whether or not such structures contain a basement. The (Floodplain Administrator) shall maintain a record of all such information.
3. All new construction within zones V1-30, VE, and V on the community's FIRM shall be located landward of the reach of mean high tide.
4. Provide that all new construction and substantial improvements within zones V1-30, VE, and V on the community's FIRM have the space below the lowest floor either free of obstruction or constructed with non-supporting breakaway walls, open wood lattice-work, or insect screening intended to collapse under wind and water loads without causing collapse, displacement, or other structural damage to the elevated portion of the building or supporting foundation system. For the purposes of this section, a breakaway wall shall have a design safe loading resistance of not less than 10 and no more than 20 pounds per square foot. Use of breakaway walls which exceed a design safe loading resistance of 20 pounds per square foot (either by design or when so required by local or state codes) may be permitted only if a registered professional engineer or architect certifies that the design proposed meets the following conditions:
  - a) Breakaway wall collapse shall result from water load less than that which would occur during the base flood; and
  - b) The elevated portion of the building and supporting foundation system shall not be subject to collapse, displacement, or other structural damage due to the effects of wind and water loads acting simultaneously on all building components (structural and non-structural). Maximum wind and water loading values to be used in this determination shall each have a one percent chance of being equaled or exceeded in any given year (100-year mean recurrence interval).

If breakaway walls are utilized, such enclosed space shall be useable solely for parking of vehicles, building access, or storage. Such space shall not be used for human habitation.
