

Final Plats shall include the items listed below.

☐ Name of the subdivision;			
$\square$ Accurate and complete legal description of the subdivision on the face of the final plat;			
$\square$ A complete survey of the section or sections in which the plat or replat is located, or as much thereof as may be necessary to properly orient the plat within such section or sections;			
☐ Boundary lines of the subdivision; of the proposed lots therein; of the rights-of-way for any streets, highways, roads, easements or other uses; and of any associated dedications; all to be indicated by accurate dimensions, bearing or deflection angles, and radii, arcs, and central angles of all curves.			
$\square$ Notation and description of any protective improvements or dedications required by the city council or otherwise provided			
$\square$ Reference to any recorded subdivision or short subdivision adjoining the subdivision.			
$\square$ Name and right-of-way width of each street or other right-of-way.			
$\square$ Location, dimensions, and purpose of any easements.			
☐ Number to identify each lot and block.			
$\square$ Addresses for each lot within the plat.			
$\square$ Purpose for which sites, other than residential lots, are dedicated or reserved.

The property described hereon is wholly or in part within the boundaries of the Irrigation District and all lots within the short plat are subject to the terms, conditions, reservations and obligations in the present and future concerning irrigation water rights-of-way and easements as may be imposed by said district in accordance with the law.

- 2. Submitted a bond or other method of security in accordance with the provisions of  $\underline{\text{YMC } 14.20.130}$  sufficient to assure completion of all required improvements.
