About this Application:

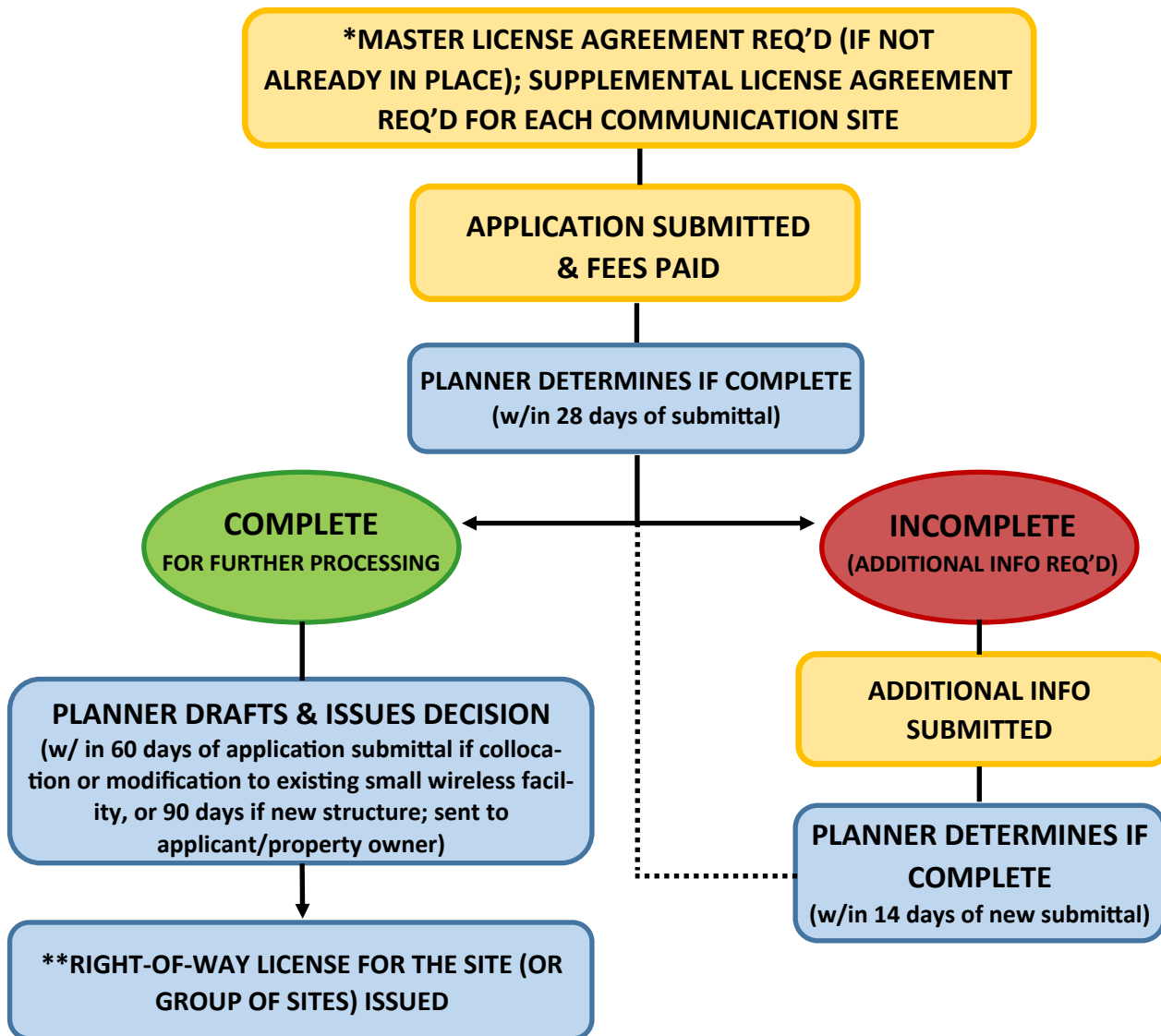

Small wireless facilities are smaller than a traditional cell tower or base station, and are typically attached to existing, replacement, or new poles or other structures in the public right-of-way. This includes technologies similar to small wireless facilities, such as microcells and distributed antenna systems (DAS). For proposals that do not meet the description above, please use the Wireless Communications Facilities application instead.

APPLICATION CHECKLIST

- ☐ Evidence that the applicant is an FCC-licensed telecommunications provider or that it has agreements with an FCC-licensed telecommunications provider for use or lease of the support structure.
- ☐ Franchise agreement, master license agreement, or other legally binding contract for the placement of small wireless facilities.
- ☐ IF NEW FACILITY - signed documentation to verify that the proposed installation will not cause physical or RF interference with other telecommunications devices, and will be in full compliance with the current FCC RF Emissions guidelines.

- ☐ Site plan drawn to scale meeting the requirements of YMC 15.29.070(B) and specified below:
 - Location within public right-of-way;
 - Volume of antenna;
 - Volume of all other wireless equipment associated with structure, including wireless equipment associated with antenna and preexisting associated equipment on structure;
 - Color of facility, including both antennas and equipment; and
 - Ground-based equipment
- ☐ Elevation drawings of the proposed wireless facility, drawn to scale and showing dimensions of the height and width of the facility.
- ☐ Engineered plans and specifications for facility.
- ☐ IF REPLACING AN EXISTING POLE OR STRUCTURE - demonstration that the facility cannot otherwise be installed on an existing pole or structure in the public right-of-way within the area that the small wireless facility is proposed to serve.
- ☐ A copy of the FCC license for the intended use of the wireless telecommunications facilities.
- ☐ If located outside of the public right-of-way, written authorization signed by the landowner authorizing the applicant to submit for permits on the landowner's behalf. The written authorization signed by the landowner shall contain a statement and acknowledgment by the landowner that the landowner shall be deemed a co-applicant by virtue of such authorization.
